Graham Foundation Announces 2025 Carter Manny Awards

Continuing nearly three decades of support for emerging scholars working to expand the discourse of architecture and the built environment

Chicago, November 12, 2025—The Graham Foundation is honored to announce the 2025 Carter Manny Awards for dissertations and research by doctoral candidates. Established in 1996, the program supports work that contributes to new narratives in contemporary understanding of architecture and its role in the arts, culture, and society.

The winner of the 2025 Carter Manny Writing Award is **Dean Michel**, Florida State University, Department of History, and the winner of the 2025 Carter Manny Research Award is **Anna Renken**, University of Toronto, John H. Daniels Faculty of Architecture, Landscape, and Design. These projects, along with five citations of special recognition, were selected by an external panel of scholars. The Writing Award includes a grant of \$25,000 and the Research Award includes \$20,000.

Michel's dissertation, "A Watery Grave in the Desert: Termination, Survivance, and the Chemehuevi Indian Tribe," explores how the Chemehuevi's livable land was destroyed by the United States federal government's construction of the Parker Dam on the Colorado River between Arizona and California in 1938, forcing a reckoning of colonial perceptions of land, value, and Indigenous sovereignty.

Renken's dissertation, "Ecological Mediations: Design with Environmental Science and Technology in Late Twentieth-Century North America," examines how architects who led laboratories at the Universities of Illinois, Southern California, and Texas developed ecological approaches through close engagement with science and technology in the period from the 1970s to the 1990s, constituting an important yet under-studied chapter in the history of environmental design.

The Carter Manny Award program—named for architect Carter H. Manny (1918–2017) in recognition of his contributions to the Graham Foundation, as founding trustee in 1956, director from 1971–93, and as director emeritus—has granted 47 awards and 149 citations representing over \$1 million in support of this important student work since its inception in 1996.

Writing a history of architectural practice through and as software history, this dissertation examines how databases of building design software structured cross-professional collaboration in architecture and construction, from office automation systems in the 1970s to commercial design software in the 1980s.

"Hammer and Machete: The Plantation in the Nineteenth-Century Urbanization of Havana" Princeton University, History and Theory of Architecture, School of Architecture

This dissertation reveals how the architecture of Havana's nineteenth-century urbanization—including the labor, material flows, techniques of construction, and organization of new professional categories—were all deeply entwined with the developments, aspirations, and fears that grew out of Cuba's system of racialized plantation slavery.

"Insurgent Rendering: Visual and Architectural Practices toward Indigenous Sovereignty in the Nagab Desert"

Northwestern University, Department of Art History

Critically examining the crisis of visibility and existence imposed by Israel on al-Araqib—an "unrecognized" Bedouin village in the Naqab—this dissertation demonstrates how collaborations between its Palestinian residents and Jewish Israelis transform visual and spatial technologies of colonial domination into insurgent tools that assert Indigenous presence and history while materializing decolonial futurity.


